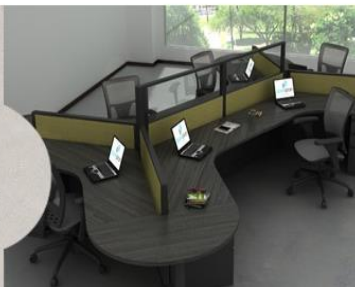

APSPM Exemption Requirements: (2.1.b.)

An agency may be granted an exemption from buying from VCE, **with the consent of both the**

DPS Director and
CEO of VCE,

in any case where

- the item does not meet the reasonable requirements of the agency,
- an identical item can be obtained at a verified lesser cost from the private sector,
- or the requisition made cannot be complied with due to insufficient supply, or otherwise.

2 Part Waiver Process

Part 1:

1. Go to VCE website at www.govce.net
2. Release process is explained and you will find the Release Form to download
3. Complete form
4. Email release request form to: vcereleaserequest@vadoc.virginia.gov
5. Once form is approved by VCE, proceed to Part 2



Part 2:

1. Complete DPS Procurement Exemption Form and submit for approval (include approved VCE release form)

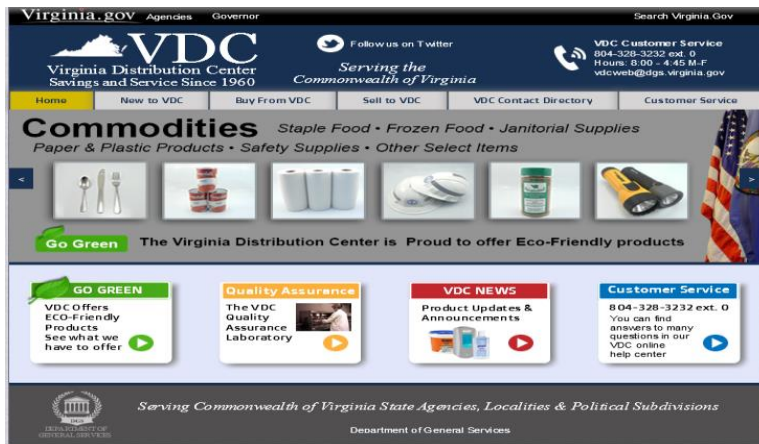

- THE IRS Standard Mileage Rate for 2015 has increased to \$0.575 per mile effective 1/1/2015.

The Office of Fleet Management Services manages the Commonwealth's centralized fleet of approximately 4,000 passenger-type vehicles. More than 175 state agencies and institutions use these vehicles for official state business.

The office administers, monitors, and enforces all rules and regulations regarding the assignment, utilization, maintenance, repair, and replacement of fleet vehicles. Additionally, it handles accident reports and a variety of citizen inquiries.

Our mission reflects the office's customer focus: To provide safe, efficient, and reliable passenger vehicle transportation that enables employees of the Commonwealth to do their jobs better and more efficiently.

The OFMS Vehicle Management Control Center (VMCC) call center is open 24 hours a day, 7 days a week, 365 days a year. If you lease or operate a state-owned vehicle please call 1-866-857-6866 for emergency roadside assistance, vehicle maintenance and mileage reporting.

Process to buy or lease a vehicle:

1. Complete OFMS-1 form and submit to DGS Office of Fleet Management via email: elizabeth.cooley@dgs.virginia.gov
2. Upon approval, proceed to DPS Statewide Vehicle Contracts and place eVA order
3. If OFMS-1 form is denied, detailed explanation will be provided and requestor can proceed accordingly

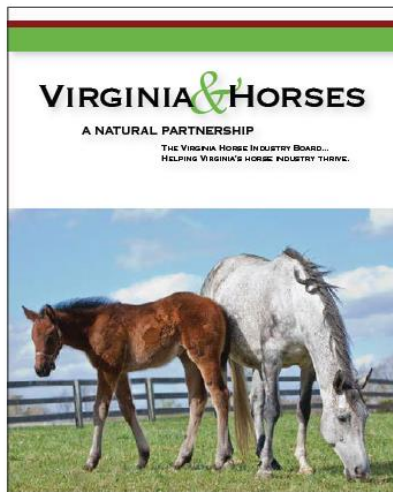

DPS – Mandatory Statewide Contracts



- 7 Agencies and institutions may not establish a contract for the same or similar goods or services or use their local purchasing authority to purchase from another source unless the purchase is exempt
- 7 Agency personnel who purchase goods or services that are on DPS mandatory contracts from non-contract sources may result in reduction or withdrawal of that agency's delegated purchasing authority
- 7 Exemptions from a mandatory state contract may be granted by DGS/DPS utilizing the procurement exemption request process
