


“**POLLING**” is the length of time from when the question is first displayed until the question is closed from further answers.

I'll *close* polling as soon as I think most people have had a chance to answer the question. The square will turn red.




In addition, your ***first response*** on the clicker is the only one that counts. You cannot change your mind.

- **Be Correct:** You only earn points for correct answers. No points are scored for wrong answers.


